## CLOUD BASED BUDGETING

The program allows intricate budgeting down to a paddock and per hectare gross margin if desired.

With the ability to project out five to 10 years, you can also use **Figured** to create 'scenarios' around purchasing more land, machinery or other major investment decisions and the subsequent impact this will have on cashflow over time.

For those in commercial business enterprises, **Futrli** is a great program for budgeting, projecting and controlling cashflows with excellent dashboard functionality to stay on top of gross margins, turnover and expense management.



### **REMINDER – GRAIN MARKETING AND INCOME DEFERRAL**

Some food for thought for our Grain growing clients...

Most businesses account for income on an accrual basis. This means you record your income and expenses when it is incurred (invoice date) and not when cash changes hands.

How does this affect grain marketing?

- **Deferred payment contracts** do not defer income, assessable at the date of invoice.
- **Defferred delivery contracts** defer income, assessable when proceeds recieved.
- **Grain pool distributions** assessable when distributions declared.
