





#### What is ESG (Corporate)

Environmental, Social and Governance (ESG) is a both a framework and a methodology to improve financial and non-financial performance. This criteria captures and critiques all aspects of a business beyond business plans and financial reporting.

#### ESG in supply chain management

ESG serves as guidelines by which supply chain management strategies should be built from bottom-line to top. Gauging a supply chain's ESG performance level would be relative to the organisation's wants and needs within environmental, social and governance action.








### Consumer Driven ESG






#### Common ESG KPI themes

The ESG Key Performance Indicators (KPIs) that appear most frequently among the 10 ESG Reporting Frameworks are as follows:
